1. **Hospital Authority:** Appointment (3) will serve a three-year term ending June 30, 2027. Meetings are typically held quarterly (January, April, July, October) on the third Tuesday of the month at 4:00 p.m. in the Executive Conference Room of the Habersham County Administrative Building. Appointments are required to complete training pursuant to Georgia House Law 769 which, in summary, requires any Hospital Authority member to complete 8 standards of education throughout a 12-month period. Each standard is 1-2 hours per session and all standards require post testing graded at 80% or higher. Any new member joining a Hospital Authority must complete and pass standard 1 before they can be sworn in as a member. The Board of Commissioners will nominate a slate of 3 names from qualified applicants for each vacancy, the final appointment will be made by the Hospital Authority.
2. **Avita Community Partners:** The appointee (1) will serve a three-year term ending June 30, 2027 and will be required to attend monthly meetings. The meetings are typically held on the fourth Wednesday of each month at 6:00 p.m. at the Avita Community Partners Building located at 4331 Thurmond Tanner Parkway, Flowery Branch, GA .
3. **Family and Children's Services Board:** The appointee (1) will serve a full five-year term ending June 30, 2029 and will be required to attend monthly meetings in addition to any required training. Online virtual meetings are typically held on the 3rd Monday of each month at 3:30 p.m. Applicants must fall under one of the following categories: Pediatric health care providers; Appropriate school personnel; Emergency responders; Law enforcement personnel; Private child welfare service providers; Alumni of the child welfare system; Mental health care providers; Former foster parents; Leaders within the faith-based community.
