PURPOSE: Habersham County would like to enter into a service agreement with J&T SERVICE CENTER, INC on maintenance of the 911 site generators. The service agreement would include semi-annual PM service on all 911 site generators. Any additional repairs and parts not included in the service agreement will be quoted to the county before any work is completed. Total service agreement comes to a cost of \$2100.00 to the County.

BACKGROUND / HISTORY: Habersham County 911 has 5 generators, 4 at tower site locations and 1 at the 911 center. The generators are required to keep the 911 center and tower sites up and running during any power outage. J&T Service Center is a trusted vendor and currently services all generators located at Habersham County fire stations. The cost of the service agreement was factored in the approved budget for 911.

FACTS AND ISSUES:

- a) The generators require annual PMs to verify they work properly.
- b) All generators have been in service for over 5 years and annual PMs are suggested for prolonged life of the generators.

OPTIONS:

- 1, Approve signing of the service agreement between Habersham County and **J&T SERVICES CENTER, INC.**
- 2. Deny approval of service agreement.
- 3. Find other vendor to quote service agreement.

SERVICE AGREEMENT

HABERSHAM COUNTY 911/RADIO TOWERS September 30, 2022

- B. Operation of coolant system transfer switch
- C. Engine charging system

- D. Speed & voltage
- E. Transfer of load with

ANNUAL INSPECTION

In addition to items mentioned above, the following services will be performed:

- A. Check air filter
- B. Replace fuel & oil filters

- C. Change lubrication oil (as required)
- D. Replace points & plugs (as required)

After each inspection the customer will be furnished a written report detailing any conditions found and advising further service required, if any, to assure operation dependability of the equipment under contract. No services, parts, or materials are under this contract unless specifically referred to herein. Any additional labor & parts for supplementary services will be invoiced as separate work. Invoicing will be rendered at time of service, due net 30 days thereafter.

This contract will automatically renew annually until cancelled in writing with 30 days prior notice by either party. We agree to correct or repair or replace any defects in material or workmanship installed under this contract which may develop under normal use within 30 days from installation. Such correction shall constitute fulfillment of any and all warranties, expressed or implied. J&T Service Center, Inc. disclaims any responsibility for consequential damages.

While periodic service and maintenance should result in maximum availability of generating equipment, J & T Service Center, Inc. makes no warranties or guarantees as to availability of plant or loss of use of equipment covered under this contract.

It is mutually understood that this proposal sets forth our entire agreement.
