## CALL OF SPECIAL ELECTION REFERENDUM FOR THE CITY OF CORNELIA, GEORGIA

"Shall the Act be approved which authorizes the	City of Cornelia, Georgia to exercise all
redevelopment powers under the 'Redevelopment Powers	Law', as it may be amended from time to time?"

All persons desiring to vote for approval of the Act shall vote "Yes", and all persons desiring to vote for rejection of the Act shall vote "No".

The last day to register to vote in the November 7, 2023 Special Election is October 10, 2023.
